19 This cause came on regularly for trial on December 13, 2000, in Department 503, the Honorable
20 Joseph A. Desmond, presiding. Plaintiff Tom Murphy appeared by his attorney, Mary McNamara, and
21 defendants City and County of San Francisco and Officer Michelle A. Kern appeared by their attorney,
22 Brian Gearing.

23 A jury of twelve persons was regularly impaneled and sworn to try the action. Witnesses on the
24 part of both plaintiff and defendants were sworn and examined. After hearing the evidence, the
25 arguments of counsel, and instructions of the court, the jury retired to consider their verdict,
26 subsequently returned to court, and being called, answered to their names and duly rendered their verdict
27 in writing, in words and figures, as follows:

28 We, the jury in the above-entitled case, find the following general verdict on the
questions presented to us:

What do you find, by a preponderance of the evidence, to be the total amount of damages

1 suffered by the plaintiff as a result of the accident on July 6, 1998, at the corner of
2 Mission and 15th Streets?

Economic Damages: \$ 6,974.11
Non-Economic Damages: \$ 35,417.00
Total: \$ 42,391.11
